\*According to the decision of the President of the Energy Regulatory Office (symbol: DRR-7129-9(6)/2015/MSI) approving a mechanism ensuring cost neutrality of the balancing measures of Gas Transmission Operator GAZ-SYSTEM, in the period from 1 October 2015 to 30 September 2016, the neutrality charge for all balancing areas is equal to zero. All costs and revenues connected with the balancing measures of Gas Transmission Operator GAZ-SYSTEM incurred during this period will be settled in the gas year 2016/2017 through the mechanism of neutrality fee rate fixed for the annual cycle. During the period from 1 October 2016 to 30 September 2016 two cost neutrality systems will operate in parallel: defined as annual and monthly. An annual settlement system, allowing TSO to settled a results of balancing activities of the Operator undertaken in 2016/2017 gas year, in which redistribution of the results will be conducted in monthly cycles.
