REGULATORY REQUIREMENTS

Obligation to publish inside information

Article 4(1) of the Regulation (EU) No 1227/2011 of the European Parliament and of the Council of 25 October 2011 on wholesale energy market integrity and transparency

REGULATORY REQUIREMENTS

Obligation to publish inside information

Market participants shall publicly disclose in an effective and timely manner inside information which they possess in respect of business or facilities which the market participant concerned, or its parent undertaking or related undertaking, owns or controls or for whose operational matters that market participant or undertaking is responsible, either in whole or in part. Such disclosure shall include information relevant to the capacity and use of facilities for production, storage, consumption or transmission of electricity or natural gas or related to the capacity and use of LNG facilities, including planned or unplanned unavailability of these facilities. (...)"

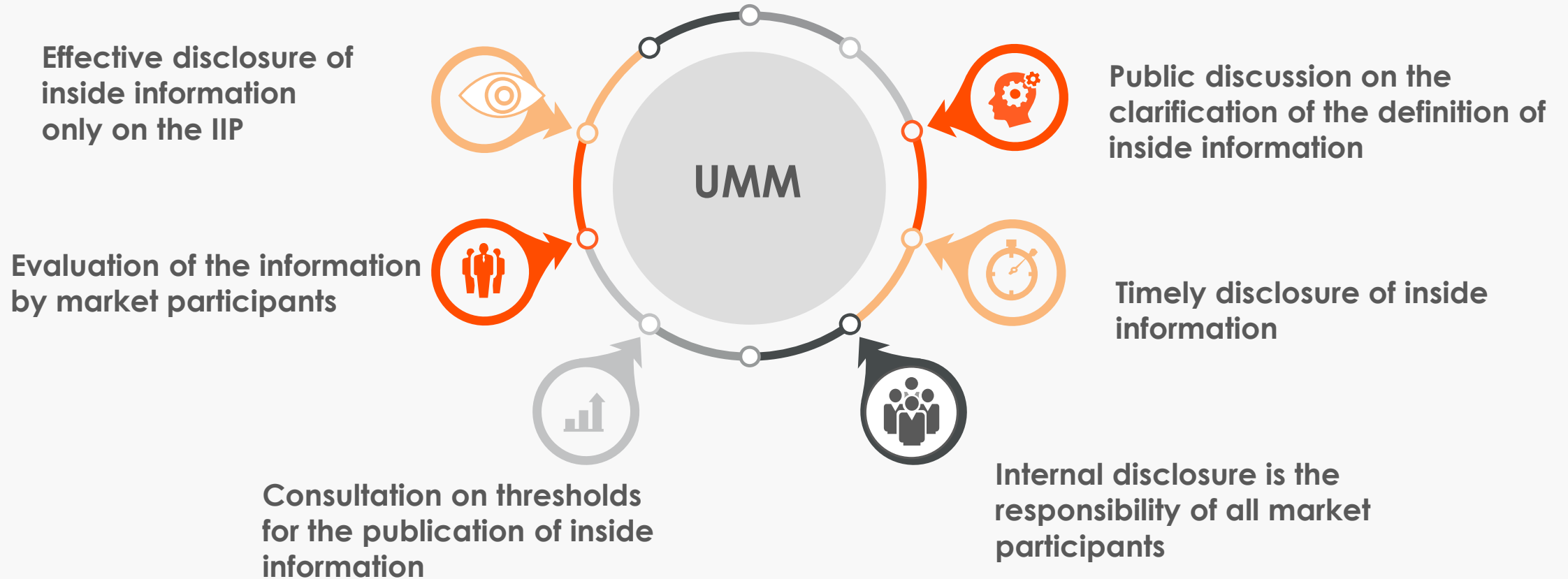

ACER GUIDELINES

Effective public disclosure of inside information on the Inside Information Platform

“The Agency believes that, in order to achieve effective disclosure according to Article 4 of REMIT, the information shall be disclosed using a platform for the disclosure of inside information (Inside Information Platform or IIP), i.e. an electronic system for the delivery of information which allows multiple market participants to share information with the wide public and complies with the minimum quality requirements listed in Chapter 7.2.2. ”

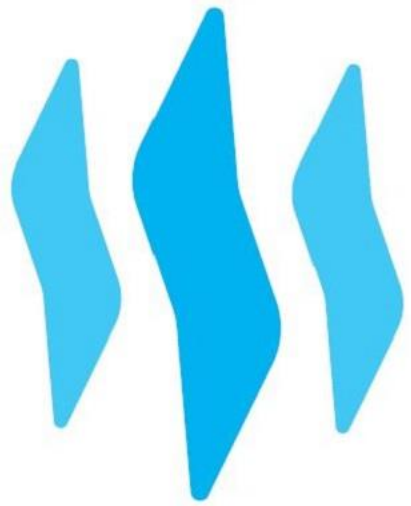
