

AMENDMENT TO THE
TRANSMISSION NETWORK CODE (TNC) OF THE
GAS TRANSMISSION OPERATOR GAZ-SYSTEM S.A.

1. Point 3.4.13 of the TNC reads: *"Subject to the provisions of point 7.13, the pressure at which the gaseous fuel is transferred for transmission at a physical entry point or received at a physical exit point shall be published on the TSO's website. A change in the value of the gaseous fuel pressure published on the TSO's website shall take place upon agreement with the relevant ISO or the Customer connected at the relevant physical exit point. "*
2. A new point is added to the TNC:
 - 7.13 Gas pressure reduction service:
 - 7.13.1 *The use of the transmission system within the scope of the allocated firm or interruptible capacity at physical exit points, where the reduction of the gaseous fuel pressure is performed by the TSO on the part of the transmission system, outside of the installation of the Customer connected to the transmission system, shall only be possible after the use of the gaseous fuel pressure reduction service.*
 - 7.13.2 *The list of physical exit points where the use of the transmission system requires the use of the gaseous fuel pressure reduction service provided by the Operator shall be published on the TSO's website.*
 - 7.13.3 *The TSO shall be obliged to provide the System User with a gaseous fuel pressure reduction service at a physical exit point from the transmission system listed in the list referred to in point 7.13.2, at the level and for the duration of the capacity of the physical exit point in question allocated to the System User.*
 - 7.13.4 *The gaseous fuel pressure reduction service shall be provided at a physical exit point at the request of the System User. It is understood that a request for capacity allocation for a physical exit point listed in the list referred to in point 7.13.2, including the allocation of capacity for technological start-up, shall at the same time constitute a request for the provision of a gaseous fuel pressure reduction service at a given physical exit point from the transmission system, at the level and for the period specified in the capacity allocation request.*
 - 7.13.5 *The provisions of point 7.13.4 shall apply accordingly in the event that the System User submits a nomination under the enhanced nomination procedure in accordance with point 7.7.*
 - 7.13.6 *The request for the provision of a gaseous fuel pressure reduction service at a physical exit point from the transmission system shall be rejected in the part in which the capacity allocation for the physical exit point in question is not concluded, either on a firm or interruptible basis.*
 - 7.13.7 *Once the capacity allocation (PP) has been made available for a physical exit point listed in the list referred to in point 7.13.2, in electronic form in the IES, the TSO shall be deemed to announce the acceptance*

of the gaseous fuel pressure reduction service at the given physical exit point to be provided to the relevant System User at the level and for the duration of the allocated capacity of the given physical exit point to that System User.

7.13.8 The provisions of points 7.13.1, 7.13.3, 7.13.4 and 7.13.6 - 7.13.7 shall apply accordingly in the event of a change in the capacity allocation (PP) for a physical exit point referred to on the list in point 7.13.2.

3. A new point is added to the TNC:

22.3 System Users who, in the gas day of 01.01.2023, use the capacity of the physical exit point listed in the list referred to in point 7.13.2, have applied for the provision of a gaseous fuel pressure reduction service at a given physical exit point from the transmission system, at the level and for the period specified in the capacity allocation for that point as of gas day 01.01.2023, and the Operator has accepted the application submitted and has started to provide the service as of gas day 01.01.2023.

22.4 When a physical exit point is added to the list referred to in point 7.13.2, it shall be assumed that the System Users who use the capacity of the physical exit point during the gas day in which the indicated physical exit point was added to the list have applied for the provision of the gaseous fuel pressure reduction service at the given physical exit point from the transmission system, at the level and for the period specified in the capacity allocation for that point, as of the gas day in which the indicated physical exit point was added to the list, and the Operator has accepted the application submitted and has started to provide the service as of that gas day.

22.5 In the event that a physical exit point is removed from the list referred to in point 7.13.2, it shall be assumed that the System Users who, during the gas day in which the indicated physical exit point was removed from the list, use its capacity, have requested discontinuation of the gaseous fuel pressure reduction service at the given physical exit point from the transmission system, at the level and for the period specified in the capacity allocation for that point, as of the gas day in which the indicated physical exit point was removed from the list, and the Operator has accepted the submitted request and discontinued the service as of that gas day.
