### Information on the collection, processing and protection of personal data of persons submitting job application documents to the Gas Transmission Operator GAZ-SYSTEM S.A.

#### Why do we need personal data?

We are looking for candidates to work in our Company. The data we collect about candidates are necessary to assess their suitability for the job and further to prove that we did not use discriminatory criteria such as gender, to select the best candidate.

#### Whom do we share personal data with?

Personal data will be processed by our employees and additionally, in some cases, by recruitment agencies on our behalf.

Access to the data may also be granted to IT service providers for our ICT systems where candidates' personal data are processed.

We do not transfer personal data to countries that cannot provide adequate protection.

#### What is the legal basis for data processing?

Providing personal data is voluntary, however, failure to provide data will prevent you from participation in the recruitment process. The legal basis for the processing of your personal data to the extent specified in your application documents (e.g. CV, cover letter) and collected during the job interview is Article 6(1)(a) of the General Data Protection Regulation 2016. (GDPR) which means in this situation that the processing of your personal data is based on your consent to the processing of such data. In addition, we process personal data to the extent necessary for the purposes of the legitimate interests pursued by our Company (Article 6(1)(f) to demonstrate our impartiality in the recruitment process, as evidence against potential charges filed by any candidate that his/her application was rejected due to discriminative procedure.

#### How long will we process the data?

Personal data collected for the purpose of the recruitment process will be processed for the period necessary to hire the best candidate.

If you consent to the processing of your personal data for future recruitment processes, your data will be processed for a period of 1 year or until you withdraw your consent.

The processing period may be extended if the processing is necessary for the establishment or assertion of claims or the defence against claims, and thereafter only if and to the extent required by law.

#### What are your rights?

You have the right to:

access your personal data, i. e. obtain information which data are processed, in what manner and for what purpose,

rectify, i. e. demand that the data be updated if they were collected incorrectly, remove the personal data, i. e. demand the removal of the personal data in whole or in part. If the request is justified, we shall immediately delete such data,

restrict the processing, i. e. demand that we limit the personal data processing to their storage. The processing restriction may be repealed after the circumstances justifying the limitation of the processing cease to exist,

receive from us in a structured, commonly used and machine-readable format personal data relating to you, for as long as we process it for the recruitment purposes

withdraw your consent to the processing of data for recruitment purposes at any time without affecting the lawfulness of the processing conducted on the basis of your consent until its withdrawal object to the processing, i. e. demand that we cease to process your personal data for the purpose indicated above if you consider that your rights related with the processing of the data you provided were infringed

file a complaint against us with the President of the Personal Data Protection Office (Prezes Urzędu Ochrony Danych Osobowych) if you believe that the processing of your personal data violates the applicable provisions of law.

#### Do we make automated decisions including profiling?

Your personal data are not used for profiling. We also do not make automated decisions.
